3. A RESOLUTION CALLING ON THE FEDERAL RESERVE BOARD TO ACT TO PROTECT BORROWERS FROM PREDATORY AND DECEPTIVE PRACTICES INVOLVING HOME LOANS
4. A RESOLUTION ENTREATING LOCAL CIVIC, PHILANTHROPIC, BUSINESS, AND SOCIAL ORGANIZATIONS, AND PRIVATE INDIVIDUALS, TO PARTNER WITH THE CITY OF PINE BLUFF IN THE 2008 SUMMER YOUTH EMPLOYMENT PROGRAM
5. A RESOLUTION APPROPRIATING THE SUM OF \$50,000 FROM SURPLUS STATE TURNBACK FUNDS TO THE ADVERTISING AND PROMOTION COMMISSION TO REIMBURSE THE COMMISSION FOR EXPENSES IN REPAIR OF THE ROOF OF THE PINE BLUFF CONVENTION CENTER
6. A RESOLUTION APPROPRIATING THE SUM OF \$6,000 FROM SURPLUS STATE TURNBACK FUNDS TO THE PARKS AND RECREATION COMMISSION TO PAY FOR IMPROVEMENTS TO THE LAKE SARACEN LANDING AMPHITHEATER
