1. AN ORDINANCE ADOPTING THE 2012 ARKANSAS FIRE PREVENTION CODE WITH REVISIONS, REFERENCE STANDARDS AND APPENDICES; AND DECLARING AN EMERGENCY (**up for the 3rd and final reading**)
