AN ORDINANCE AMENDING SECTION 26-155 OF THE CODE OF ORDINANCES OF THE CITY OF PINE BLUFF, ARKANSAS, REGARDING DOWNTOWN LIMITED TIME PARKING; PENALTY FOR EXCEEDING TIME LIMIT, TO ADD SUBSECTION (D) CONCERNING PARKING ALONG BARRAQUE STREET NEAR AND IN FRONT OF THE JEFFERSON COUNTY COURTHOUSE, AND FOR RELATED PURPOSES (up for the 3rd and final reading)
