AN ORDINANCE AMENDING SECTION 26-155 OF THE CODE OF ORDINANCES OF THE CITY OF PINE BLUFF, ARKANSAS, REGARDING DOWNTOWN LIMITED TIME PARKING; PENALTY FOR EXCEEDING TIME LIMIT, TO ADD SUBSECTION (D) CONCERNING PARKING ALONG BARRAQUE STREET NEAR AND IN FRONT OF THE JEFFERSON COUNTY COURTHOUSE, AND FOR RELATED PURPOSES (up for the 3<sup>rd</sup> and final reading)
2. AN ORDINANCE AMENDING THE JOB DESCRIPTION FOR THE POSITION OF ASSISTANT CHIEF OF POLICE IN THE POLICE DEPARTMENT; REQUIRING THAT NO PERSON MAY BE PROMOTED TO THE POSITIONS OF DEPUTY CHIEF OF POLICE WHO DOES NOT HOLD THE RANK OF CAPTAIN (OR EQUIVALENT), AND THAT NO PERSON MAY BE PROMOTED TO THE POSITIONS OF ASSISTANT CHIEF OF POLICE WHO DOES NOT HOLD THE RANK OF DEPUTY CHIEF (OR EQUIVALENT), AND FOR RELATED PURPOSES, AND DECLARING AN EMERGENCY (up for the 3<sup>rd</sup> and final reading)
3. AN ORDINANCE PROHIBITING THE PURPOSEFUL REMOVAL OR DAMAGING OF SIGNS (up for the 2nd reading)
4. AN ORDINANCE PROVIDING THAT THE CITY INSPECTION DEPARTMENT WAIVE ANY PERMIT AND INSPECTION FEES FOR PROSPECTIVE PURCHASERS OF REAL ESTATE IN THE DOWNTOWN AREA (up for the 2nd reading)

AN ORDINANCE REQUIRING THAT ALL MEETINGS OR CONFERENCES CONCERNING CONSTRUCTION AND RENOVATION PROJECTS OR CITY FACILITIES SHALL INCLUDE THE MAYOR, MEMBERS OF THE CITY COUNCIL, THE FINANCE DIRECTOR, AND THE PROJECT MANGER(S), AND THAT NO FUNDS BE EXPENDED FOR ANY PROJECT UNLESS PREVIOUSLY APPROPRIATED OR AUTHORIZED BY THE CITY COUNCIL (up for the 1<sup>st</sup> reading)
