Free Tax Return Filing In Jefferson County

Need help filing your tax return?

The Pine Bluff Wealth Building Coalition is pleased to announce two Sites offering Volunteer Income Tax Assistance (VITA) to all residents in Jefferson County and surrounding areas.

What is VITA?

The Volunteer Income Tax Assistance program is an IRS tax program that offers **FREE** tax filing services to individuals and families with an annual earned income of \$54,000 (MFJ) and below.

When, where, and how?

Free tax return filing will be conducted at the Super Saturday event on February 6, 2016 from 9 a.m. to 3 p.m. at the Donald W. Reynolds Community Services Center located at 211 West Third Avenue.

If you are unable to attend the Super Saturday event, please visit one of the free filing VITA site locations listed on the left-hand side of the page.

What to bring:

- Social Security cards for yourself and your dependents
- Your picture ID
- W-2's for all jobs held in 2015
- Form 1095's (1095-A, 1095-B, 1095-C) Health Insurance Statements
- Form 1099's (1099-G, 1099-MISC, 1099-INT, etc.)
- Form 1098-T (tuition expenses)
- Form 1098 (Mortgage interest payment)
- Documentation of childcare expenses and childcare provider information (agency ID or SSN of the provider)
- Voided check or deposit slip for direct deposit

If you are filing Married Joint, both taxpayers need to be present

- **Take the money, you've earned it!** Learn more about the **Earned Income Tax Credit (EITC)** and **Child Tax Credits** while we assist you with your taxes.
- Our dedicated and knowledgeable **tax volunteers** are **IRS-certified** and can help you get the maximum tax credits you may be entitled to.
- **FREE electronic filing.** All tax returns are filed electronically, which means you can get your refund in half the time of a return filed on paper. You can get your refund even faster if you have your refund deposited directly into your bank account.
